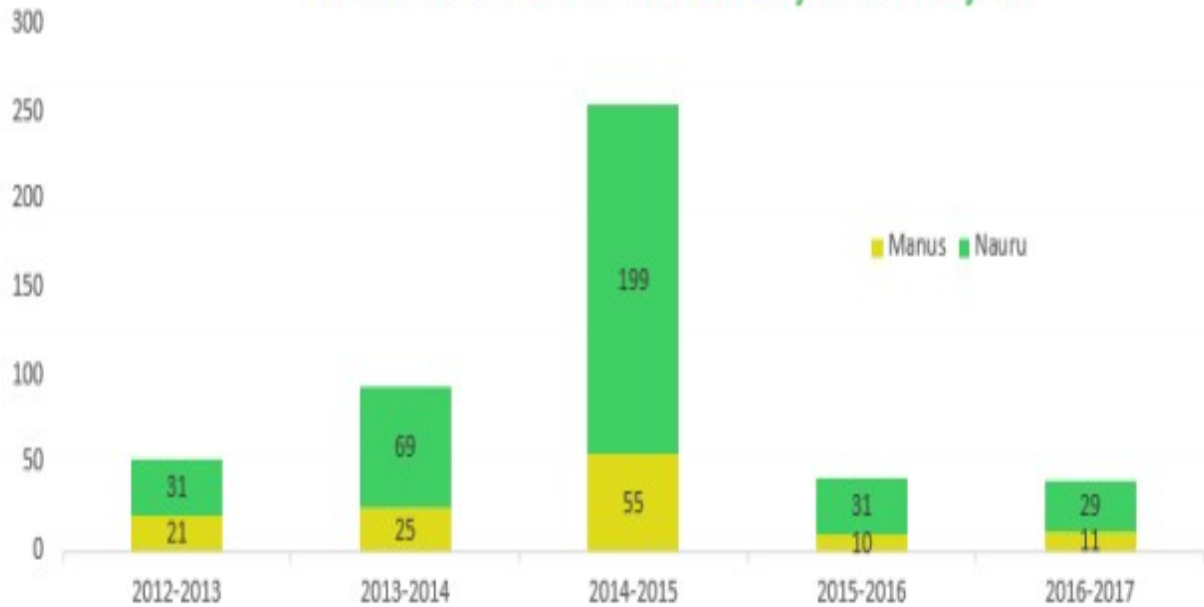

9. Please outline how many people have been denied medical transfer requests from Manus Island for the past five financial years.
10. Please detail if the Overseas Medical Referral process is still operating on Nauru and, if not, on which date did it cease.
11. Please detail the Departments role in Medical Transfers of refugees from Nauru.
12. Is it Departmental policy for parents undergoing a medical transfer to leave their children on Manus or Nauru?
